### INSTRUCTION

1. All the communication must be addressed to the Registrar of the Council.
2. Please keep this book with you carefully.
3. For renewal of registration : -
  - [a] Prescribed renewal fees with late fine (if any) must be paid.
  - [b] Bring this Book with an application with present address.

**Registrar's Power to withhold Registration :** In regards to the four conditions contemplated in sec. 32 (2) of the Act, it is the duty of the applicant to produce relevant documents and materials to satisfy the Registrar about the fulfilment of the conditions by him. If such documents are not produced alongwith the application, it is open to the Registrar to call upon the applicant to produce such documents Regarding Conditions (i) to (iii), namely, payment of prescribed fee, age residence or carrying on business or profession of Pharmacy in Assam State, it is for the Registrar to satisfy himself and it is for the applicant to satisfy the Registrar. Regarding one of the alternatives in the fourth condition, namely, that the applicant is a registered Pharmacist in another state, the satisfaction of the Registrar rests on evidence of registration in another state and he has no jurisdiction to go to behind the registration granted in another state or to see whether the registration was granted validity or not. If an applicant involves the other two alternatives in the fourth condition, he must satisfy the Registrar that he has passed the examination or possessed the qualification.
